Patrons planning to reproduce/publish photographs in books, articles, exhibits, videos, electronic transmission (publishing an image on a web site, for example) or other media must request permission in advance by submitting this Reproduction Use Form. Permission will normally be granted as long as applicable use fees are paid and donor or copyright restrictions do not prohibit the intended use. *The long-term preservation of the image is the primary concern of the archives and as such, the archives reserves the right to limit reproduction due to age, condition or format.*

Permission for reproduction is for **one-time use** and is limited to the applicant and is nontransferable. Permission for reproduction is granted only for the expressed purpose described in this application. Any subsequent use constitutes reuse and must be applied for in writing. Any change in use from that stated on the application requires permission of the Champaign County Historical Archives. An additional fee may be charged for reuse or change in use. This permission is non-exclusive; the Champaign County Historical Archives reserves the right to reproduce the image and to allow others to reproduce the image.
